### SECTION 4. FIRST-AID MEASURES

- IF SWALLOWED, WASH OUT MOUTH WITH WATER PROVIDED PERSON IS CONSCIOUS. CALL A PHYSICIAN IF INHALED, REMOVE TO FRESH AIR. IF NOT
